**THE OKLAHOMA HORSE FAIR RELEASE,
ASSUMPTION OF RISK, WAIVER, AND INDEMNIFICATION**

I agree in consideration for my participation in this equine event to the following:

- I AGREE that I choose to participate voluntarily in the Russel Dilday Horsemanship Clinic with my horse, as a rider, handler, lessee, owner, agent, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and performing in equine events involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death (“Harm”).
- I AGREE to release The Oklahoma Horse Fair from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of The Oklahoma Horse Fair.
- I AGREE to expressly assume all risks of Harm to me, or my horse, including Harm resulting from the negligence of the Stephens County Fair & Expo Center or The Oklahoma Horse Fair.
- I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Stephens County Fair & Expo Center or The Oklahoma Horse Fair and to hold them harmless with respect to all claims for Harm to me, or my horse, and for claims made by others or any Harm caused by me, or my horse at The Oklahoma Horse Fair.
- If I am a parent or guardian of a junior exhibitor, I consent to the child’s participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child’s behalf.
- I AGREE that The Oklahoma Horse Fair and Stephens County Fair & Expo Center as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers, and affiliated organizations.
