1. All breeds of horses, mules and ponies may be shown. Any age horse or rider is eligible.
2. Riders under 18 years of age must have written release from parent or guardian.
3. OKHF, Western Heritage Sales Co., and employees are not responsible for accident, sickness, or death of livestock.
4. Original individual negative coggins test within 12 months of event date required.
5. Entry Fee - \$150 per horse/rider; rider may enter a maximum of 2 horses. Deadline for entries: February 8, 2010
6. Stalls available @ \$20.00 each; stalls furnished with 1 bag of shavings. Additional shavings available @ \$5.00 per bag.
7. Horses selling in the Select Sale on Saturday will receive a \$25 catalog fee discount and will not be charged for stalls.
8. Type of equipment to be used on your horse is at your discretion, with humane means.
9. Your attire should consist of a long sleeve shirt, boots, jeans, and cowboy hats. No ball caps!
10. Contestants are responsible for their own tack, barn equipment, feed, hay, etc.
11. Proper sportsmanship to fellow competitors and humane treatment of all animals is expected. Anyone not complying may be asked to leave the premises. All unsound animals will be dismissed.
12. One hour prior to the start of the competition, the contestants will meet in the main lobby to draw for order and to review the rules.
